## Federal Legislative Alert: Problematic PUPS Bill Reintroduced for 2013 (Friday, March 01, 2013)

Federal "PUPS" legislation (S 395/HR 847), sponsored by Sen. Richard Durbin (D-Ill.) and Rep. Jim Gerlach has been reintroduced in the U.S. Congress and assigned to the House and Senate Agriculture committees. The bill is substantially the same as previous versions introduced in 2011 and 2010, which never received committee hearings.

The AKC continues to express grave concerns about this measure. The AKC believes that all dog breeding programs should be undertaken responsibly and does not oppose the concept of regulating high volume breeder-retailers. However, as currently written, the definitions proposed in this bill are misleading, overly broad, and potentially damaging to small responsible breeders who individually maintain and breed only a few dogs in their homes.

Although the stated purpose of PUPS is to regulate internet sales of puppies, S $395 / \mathrm{HR} 847$ as currently written would require anyone who owns or co-owns even a few female dogs that collectively produce 50 or more puppies offered for sale in a year to be regulated under existing USDA dog "dealer" regulations. These regulations are designed for high-volume commercial kennels that produce puppies for wholesale or research, and require a USDA commercial license, maintenance of specified commercial kennel engineering standards and regular inspections. These requirements are not appropriate for small breeders who may keep only a few dogs in their homes.

AKC's specific concerns with PUPS include the following:

* Defines "high volume retail breeder" as someone with "an ownership interest in or custody of one or more breeding female dogs". This definition is overly broad and does not take into account co- and joint ownerships common among dog owners, dog show participants, hunting club members, sporting dog trainers and other hobbyists. This would hurt many small hobby breeders who keep or breed only a few dogs in their homes by subjecting them to commercial standards of regulation as a result of agreements they maintain with other small breeders.
* Defines "high volume retail breeder" as someone with "an ownership interest in or custody of one or more breeding female dogs". Because the threshold for regulation is based on the number of dogs bred and sold, any reference to the number of dogs owned or in custody is unnecessary and potentially misleading.
* Defines "breeding female" as an intact female dog aged 4 months or older. This is misleading and implies that a female dog may be bred at 4 months. Female dogs are not sufficiently mature at 4 months of age to be bred and should not be deemed "breeding females".
* Exercise language should be clarified with respect to the terms "solitary and goal oriented" to ensure that the daily exercise requirements do not preclude training that involves other types of wholesome activity that could fall under this definition (e.g., playing fetch, field training for hunting dogs, or the responsible use of treadmills for keeping canine athletes in top physical condition).
* PUPS would exponentially expand the pool of breeders regulated and inspected by the Animal Care Division of the United States Department of Agriculture's (USDA) Animal, Plant and Health Inspection Service (APHIS). However, a May 2010 audit of this program by the USDA's own Inspector General demonstrated that the existing inspections program is insufficient to carry out current responsibilities. AKC believes these issues and full funding for the current program and enforcement of current laws should be addressed before attempting to exponentially expand the program's responsibilities and workload.

AKC encourages you to respectfully share these reasonable concerns about the potential damaging consequences of this bill with your member of Congress.

The RI State Vet and the RI Department of Environmental Management (DEM) armed officers showed up and wanted to check everyone for health certificates and also the presence of any illegal (ownership permit required from state) breeds. On Face Book people reported they wanted the names and addresses of everyone but the show committee would not give them any information. Some exhibitors left immediately. No animals were seized and no citations were issued. But everyone was terrorized.

In light of what happened at the Rhode Island cat show it seems a good time to review VA's regulations.

## Residents of Virginia, and People Moving to Virginia:

If you are a resident of Virginia, or are moving to Virginia, there are no entry requirements for you to bring in your personal pet dogs
 and cats. Please note, however, that you will need to ensure that any dog or cat over four months of age is currently vaccinated for rabies and that county or city licenses are required for all dogs and may be required for cats.
If the dog or cat is intended to be used for any purpose other than being a personal pet (such as offering it for sale or adoption, breeding it, or using it for promotional purposes) the dog or cat will need to be accompanied by a Certificate of Veterinary Inspection (CVI) issued by a veterinarian in the state or country the animal is coming from 10 days or less before the animal enters Virginia. If the dog or cat is over four months of age, it must be vaccinated for rabies.

## People Visiting Virginia:

There are no requirements if you are only transiting through Virginia and the dog or cat remains under your control at all times. If you are visiting Virginia with your dog or cat, you will need a Certificate of Veterinary Inspection (CVI) issued by a veterinarian in the state or country the animal is coming from 10 days or less before the animal enters Virginia. If the dog or cat is over four months of age, it must be vaccinated for rabies. A CVI is not required if the dog or cat is entering Virginia for 10 days or less for exhibition or hunting purposes.

## Animal Shelters, Humane Societies, and Animal Rescue Groups:

All dogs and cats brought into Virginia by animal shelters, humane societies, and rescue groups will need to be accompanied by a Certificate of Veterinary Inspection (CVI) issued by a veterinarian in the state or country the animal is coming from 10 days or less before the animal enters Virginia. If the dog or cat is over four months of age, it must be vaccinated for rabies.

Breeders, Dealers, Pet Stores, and other Commercial Entities: All dogs and cats will need to be accompanied by a Certificate of Veterinary Inspection (CVI) issued by a veterinarian in the state or country the animal is coming from 10 days or less before the animal enters Virginia. If the dog or cat is over four months of age, it must be vaccinated for rabies.

## 6 Ways Your Dogs Can Give You a Tax Break Some costs of dog ownership can be deductible, but only if you fall under certain categories.

We love them, play with them, groom them, and go to great lengths to care for them. And who can blame us? They're members of our family. We want the best for them and we indulge them with new toys, fancy food, or plush beds whenever our budget allows it. And when the worst happens and our dog gets ill and needs extensive veterinary care, we find a way to scrape up the money to make our best friend better.

So when tax season rolls around, many pet parents might be thinking how their dogs might be considered as dependents or legitimate tax deductions.

Caring for our furry friends isn't cheap. Collectively, pet parents in the U.S. spent $\$ 53$ billion last year, according to the American Pet Products Association. The individual cost of raising a dog ranges from \$1,314 annually for smaller breeds to $\$ 1,843$ a year for big dogs, according to the ASPCA. This figure includes dog food, pet insurance coverage, basic preventative veterinary care, and grooming costs.

A few years ago, there was a movement to relieve some of burden of pet care costs. A bill was introduced to Congress, H.R. 3501, called the "Humanity and Pets Partnered through the Years" (or, HAPPY). Michigan Rep. Thaddeus McCotter introduced the bill, along with Rep. Steve Cohen of Tennessee and Rep. Jared Polis of Colorado, in the hopes of reducing pet parents' financial burdens by allowing a $\$ 3,500$ tax deduction per year. Although the bill was endorsed by many organizations (including the ASPCA, the Humane Society of the United States, the Animal Law Coalition, the American Veterinary Medical Association, and the Pet Industry Joint Advisory Council), it failed to garner enough votes to pass.

So if Uncle Sam isn't going to give pet parents a break, is there anything else that can be done? Well, maybe. Lisa Greene-Lewis, lead CPA at the American Tax and Financial Center at TurboTax, says there are some legitimate tax deductions for pet parents, but only in specific instances. She cautions taxpayers to tread carefully when making these deductions by having receipts and documentation to back up these claims, should the IRS decide to audit your return.

Here are six instances where you could make a deduction:

## 1. Service dogs

If you or your dependent receives assistance from a service dog such as a seeing-eye dog, you can deduct the cost of buying, training, and caring for the dog. Such dogs are considered medical expense deductions.

## 2. Guard dogs

If Fido guards your place of business, you would be able to write off expenses for care and feeding. However, Uncle Sam is not going to approve of a deduction for a Chihuahua or

Pekingese, not matter how fierce they act. Your deduction is less likely to raise an auditor's eyebrow if your dog is a traditional guard breed such as a Rottweiler, German Shepherd, or Doberman Pinscher.

## 3. Breeders

Dog breeders can claim the care and feeding expenses for their dogs and puppies as a business deduction, as long as breeding is their career and not a hobby, says Greene-Lewis. If you have a space on your property dedicated exclusively to breeding, it is also a viable business deduction.

## 4. Pet actors

Taxpayers who are lucky enough to have a pet in show business can deduct some of the expenses directly related to the business, as long as the expenses are reasonable. And no, we're not talking about that cute video of Bowser chasing his tail that you uploaded to YouTube last week.

## 5. Adoption

Good news! Not only can you save a dog's life, but you can deduct the cost of the donation for adopting the dog. These adoption fees typically cover shots and the cost of a spay or neuter surgery.

## 6. Foster care

If you directly foster a dog for an animal shelter or rescue organization, you can deduct expenses such as vet bills, boarding, food, collars, leashes, medication, and toys. If you've been on the fence about whether to foster dogs, perhaps this news will tip fostering in your favor.

Hopefully, these tax tips will provide some guidance on what pet-related tax deductions are legal in the eyes of Uncle Sam. If you have any further questions, it's best to consult an enrolled agent or CPA to get expert advice.

And if you'd like to see your fur kid eligible as a tax deduction in the future, contact your Congressional representative!
