Salmon Delights

6 ounces of Salmon 1 Tblsp of Salmon Oil

1/3 Cup of Garbanzo Bean Flour

1 Cup of Rice Flour

½ tsp of ground Fennel (optional, aids digestion and good for gas)

Preheat oven to 350 degrees. Puree salmon and mix with rest of ingredients. If dough too dry add a little water, if too sticky add more flour. Flour surface with either rice, tapioca or regular flour. Roll out dough to ¹/₄ inch and cut into shapes. Bake for 30-40 minutes until desired crunchiness. Makes about 5-6 dozen treats. Keep in a cool place or freeze.



Civil Immunity for private citizens who break into cars to rescue an animal they believe is in distress VFDCB REGULAR Meeting 5 January 11, 2016

There were actually four bills -- all identical -- about granting immunity for breaking into cars. They were HB 38, HB 211, HB 1323, and SB 9. Here are the links for each of them.

The VFDCB and the AKC strongly agree that no person or animal should ever be left in a situation where their health or safety are in danger. Those who would leave them in such a situation – including a vehicle – should be held accountable.

We are concerned, however, that these bills, as introduced, could lead to unintended consequences that would harm animals and punish responsible owners. A new trend on the rise across the United States is known as "dog flipping", where dogs are stolen and then resold online for a profit. The AKC's National Pet Theft Database shows that in 2014, there was a 4.5% increase in pet theft over the previous year. The statistics have dramatically increased since the AKC began tracking this trend in 2008.

All the House Bills have been tabled for this session and the Senate Bill has been amended to just cover civil immunity for first responders. It has been approved in the Senate and is currently awaiting action in the House.

As presented the three House bills would have allowed – and held free from liability – someone without law enforcement powers to break into a person's car using force to remove an animal. We appreciate that these bills would have required the person to first attempt to contact appropriate law enforcement or animal control officials. However, in order to prevent pet theft – and the potential for allowing a dog to roam at large causing even more harm to the dog and/or the public – we recommend that any person who breaks into a car to free an animal be required to stay with the vehicle and animal, or at least in the vicinity, until a law enforcement official arrives. We further recommend that a person should not be permitted to leave the scene if the location of the animal is unknown.

Additionally, bills like this should allow for recourse for the owner if they did in fact take proper steps to ensure the animal's safety was protected (such as proper ventilation, air conditioning, blankets, or other protocols appropriate for the breed of dog). Owners should also be exempt from liability for their dog harming someone as a result of breaking into the vehicle. Most animals would view the car as their "personal space" and would try to guard it. These protections are especially important if the animal flees the car and becomes at large.

We have shared our concerns with the sponsors of these bills (particularly Delegate Kory) and offered to work with them to craft bills that incorporated our suggestions.

VFDCB supported two companion bills to improve ACO training - HB1211 and SB651. They are mirror images and have passed both chambers and are on the way to the Governor for his

signature. Under current law ACOs have two years to complete their training. These bills reduce that period to one year with some exceptions.

Delegate Bobby Orrock has proposed a study HJ160 to have licensing of dogs and cats done at the state level not the county. One goal is to create a statewide data base the all law enforcement can access. It has passed both chambers. We will be watching this one closely.

An excerpt:

WHEREAS, notwithstanding these actions, the present system for licensing at the local level does not ensure a high level of vaccination compliance, is plagued by licensing noncompliance, and leaves animal control officers and other public safety officials without access to a statewide data resource regarding animals, thereby rendering animal control efforts more difficult and less effective; now, therefore, be it

RESOLVED by the House of Delegates, the Senate concurring, That the Virginia Department of Health be requested to study Virginia's procedures for licensing dogs and cats.

In conducting its study, the Virginia Department of Health shall review Virginia's companion animal licensing procedures and assess the feasibility of establishing a statewide system for recording rabies vaccinations and licensing that may include a statewide database of licensed companion animals that can be remotely accessed by animal control officers in the field. The Department shall be assisted in its work by a panel of stakeholders chosen by the Commissioner of Health. The panel of stakeholders shall include representatives of local government, the Virginia Animal Control Association, and the Virginia Veterinary Medical Association and citizens experienced in animal welfare issues.

The Virginia Department of Agriculture and Consumer Services shall provide technical assistance to the Virginia Department of Health for this study. All agencies of the Commonwealth shall provide assistance to the Virginia Department of Health for this study, upon request.

VFDCB REGULAR Meeting 7 January 11, 2016

The Virginia Department of Health shall complete its meetings by November 15, 2016, and report its findings and recommendations to the Chairman of the House Committee on Health, Welfare and Institutions and the Chairman of the Senate Committee on Education and Health by December 1, 2016, and shall submit to the Governor and the General Assembly an executive summary and a report of its findings and recommendations for publication as a House or Senate document. The executive summary and report shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports no later than the first day of the 2017 Regular Session of the General Assembly and shall be posted on the General Assembly's website.

There has been a lot of talk about HB 340 sponsored by Delegate Orrock. Support. http://lis.virginia.gov/cgi-bin/legp604.exe?161+sum+hb340

After much discussion among all the constituents - primarily the public and private shelters in Virginia - this is the final version of the bill. It is moving through both chambers.

Be it enacted by the General Assembly of Virginia:

1. § 1. That the Board of Agriculture and Consumer Services shall adopt regulations that determine whether a private animal shelter meets the purpose of finding permanent adoptive homes for animals.

Another bill that caused a lot of talk is HB 476 carried by Delegate Farris. Support.

This bill seeks to have the intake policies of shelters and rescues reported and kept on file. It would add transparency to show that many such places have very restricted intake - lots of private shelters take no strays or animals that are not likely to be easily adopted. Such policies are a way to keep their euthanasia rates low. The bill has now run into some difficulty since VDACS says there will be a fiscal impact.

According to VDACS, this bill will require an expansion of the existing Animal Custody Record Online Reporting System to include a new module to collect the intake policy. Based on costs of similar systems, the department anticipates that \$51,000 the first year from the general fund is necessary for implementation of this new module, and \$6,000 each fiscal year thereafter to maintain and administer this requirement.

The bill has passed the House and in the Senate it passed the Agriculture Committee but got referred to the Finance Committee. It is probably doomed.

HB 156 - SUPPORT - Also carried by Delegate Orrock, details how VDACS will prepare and promulgate guidance documents. This bill passed the House but the Senate Agriculture Committee voted to continue the bill to the 2017 session.
