Preparation: George begins with the psychology and philosophy of showing dogs, preparing both the dog and the handler for the BOB, Group, and BIS rings. He also expands on the fine points of training, feeding, and veterinary care for the dog. In addition, George discusses the physical and mental conditioning aspects of showing.

Demonstration: You will learn the process of evaluating a dog. By the end of this clinic, each participant will be able to evaluate any dog and determine what adjustments should be made to present proper breed type.

Prerequisite: You must have attended a previous Alston Handling Seminar as an advanced or beginner handler, or observer. The Super Advanced Clinic starts where the previous seminar ended.

We just got back Mon. the 23rd. from 10 days in Huron, OH for the Whippet Natl' (between Toledo \& Cleveland). Here's my report -- we were in just about everything:
In the all-breed agility trial, I had my usual 6 dogs entered. Ashley got her first Open JWW leg \& 2nd place while Travis got a 1st place on an Open JWW leg that he didn't need. In the Standards classes, Holly was the only one of my dogs who Q'd. She got a Nov.Stnd 20" leg \& while she placed 5th in the class, it was a 4th as far as number of Q'd Whippets in the class of 10 .
Lure coursing wasn't so great either. Of the 6 I had entered in that, Nikki came the closest but lost the tie for 5th place. For 'comic relief' Ashley won the Turtle Award for the $2 n d$ yr. in a row (lowest score of 150 Whippets in the trial). This year they called it "Here for the Party" though! That's my girl!

Things got better though on Monday. I had 5 entered in Rally. My underachiever Holly actually got an Advanced A rally leg with a score of 90 and earned a 2nd place. Ashley \& Nikki both got an RAE leg \& Ashley got a 96 \& 3rd place in the Advanced B class. In obedience, I had 2 in Veterans obed. \& 2 in Novice. Nikki \& Ashley were in Veterans obedience. Ashley anticipated the recall but still got a 4th place. Nikki got a real qualifying score \& 2nd place. Travis (who has a UKC CD) earned his first AKC CD leg (we won't mention the score). Tyler just couldn't pull a qualifying score
out of his Novice class. Monday evening was the conformation competition for just the dogs entered in the Triathlon \& Versatility. Ashley got a 2nd place in the Versatility conformation.
There were only 11 dogs entered in Versatility. This included lure coursing, agility, rally, \& the above mentioned separate conformation class.
Ashley was 4th, Nikki 8th, Shannon 10th, and Tyler 11th.
There were 35 dogs in the Triathlon. This included lure coursing, obedience, \& the above mentioned separate conformation class. Nikki was16th; Travis tied for 18th, Ashley 30th, \& Tyler 35th in that competition. We'd done better last year in this when Tyler was 5th \& his Mom Shannon was 8th. In regular conformation classes later in the wk., Nikki was 3rd in the Veteran 10-12 class. Ashley \& Tyler each "made the cut" in the Veterans 7-10 classes they were in.

## Virginia Federation Report

Most of you have seen the internet buzz today about the new regulations from APHIS/USDA. Yes this IS serious: Either we will all get involved now or most of us will effectively lose our right to breed dogs. Here are some key points:
-- The regulations are proposed, not yet in effect, and the public has 60 days to make comments and attempt to make changes, starting next week.
-- Whereas many proposed laws affect only large-scale breeders, these regulations will apply to anyone who has more than four breedable bitches and sells at least one puppy.
-- If you have more than four breedable bitches and you don't want to be inspected by the federal government, the regulations require you to sell all puppies from your home. No shipping, no meeting at the rest stop, no buying a puppy from someone who meets you at a show. This requirement is for every sale, which means if you sell a puppy to one of your current owners, that person has to come to your home again -- it is one visit per sale.
-- You may sell only puppies that were born and raised at your home. That rules out stud fee puppies, puppies back, and any other puppy not born at your home.
-- If you stick to these requirements, you will not have to have USDA inspections. (Retail pet stores are not inspected because they are "inspected" by their customers. The claimed point of these regulations is to be sure OUR "customers" inspect us.)
-- If you never have more than four breedable bitches then you aren't covered by this regulation. The government won't bother you. However, "I'm not planning to breed her" or "She is too old" or "She belongs to my sister" or "I'm showing her for a client" ARE NOT EXCUSES. The wording is 'maintain,' i.e., if it's in your place and you're feeding it and it is female and could be bred, it counts.

We have always insisted that our prospective puppy owners come to our home because we think it's important for them to meet us, meet the mother etc.
We don't ship. But that is our CHOICE and it is a very personal one. I can think of any number of reasons not to open your home to the public, including personal safety, health concerns for other people in the home, contagion concerns for the puppies, a driveway you need a four-wheel drive to maneuver, and the list goes on and on. And of course there have been cases where we made an exception: Selling to someone who was already a friend, selling a second puppy to someone who came here when she bought a first pup from us, and so on. We would have to stop doing these things.
-- As currently written, this will also affect rescue. Whether you call it an adoption fee or a price, the law considers it a sale, and all sales of dogs are covered. We're still working on exactly how this might be applied to rescue, but there is currently no exemption.

Another thought: Even if this does not affect you directly, how will it affect the gene pool of your breed? I'm quite sure there are breeders who will stop breeding when the government starts requiring that we allow people into our homes. At what number of breeders quitting does the gene pool begin to shrink a an alarming pace?
