Classes with jumps will run in descending jump height order,  
beginning with the highest jump in all trials. Exceptions to jump height running  
order may be made for handlers with multiple entries.  
Rally Trials will run concurrently.

Judges are not required to wait for dogs. It is the responsibility of the owner or  
handler to have the dog at ringside when its class is called.

**Transfers will not be allowed after closing,**  
except in the case of ineligibility as per AKC rules and regulations.

Refund for bitches in season (less administrative fee) with veterinarian's note.

## IMPORTANT INFORMATION RELATED TO COVID 19

- Exhibitors are expected to follow state, local government, event and facility guidelines. A Covid Release Form must be signed in order to receive your armband.
- Limited crating will be available indoors – each class will be allowed to come in and set up a crate and chair before their class and will need to pick up everything and leave when the class is over so the next class can enter and set up. No crates will be left in the building overnight.
- Club crates and chairs will not be available for use.
- Because of limited crating, NO UNENTERED DOGS will be allowed
- **No Spectators, please**
- **Parking** – Please leave space between cars to allow for more space for those working from their cars
- **Masks** – Masks will be required when in the building
  - Masks are not required when you are in the ring. You can remove your mask upon entering the ring and put it back on before you exit the ring.
- **Check-in** will be self-serve. Please bring your own pen and maintain social distancing.
- **Course maps**
  - Only a few paper course maps will be available
  - Course maps will be posted at the site in several locations
- **Briefings and walk-throughs may be divided into smaller groups**
- **Ribbons may be self-serve**
- **There will be no food available on the site.**
- **When done for the day, exhibitors should leave the building in order to minimize congregating.**

Due to spacing limitations only the dog entered in the class being held will be allowed in the building. If you have multiple dogs in multiple classes, the ones not showing must be out of the building.

## INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.

3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

4. Dogs listed in the AKC Canine Partners<sup>SM</sup> Program may be eligible to enter all-breed AKC Obedience & Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
